HOUSING OPTIONS: (choose one)

Independent housing: You will book and manage your own housing accommodations, independently from SRISA housing

SRISA Housing: You will book and pay for your housing through SRISA (housing@srisa.org). You must request SRISA housing by Tuesday, April 1st. The SRISA housing deposit and fees will be billed and paid directly between you and SRISA without ArtU involvement. SRISA housing fees are non-refundable after April 1st.

- \$250.00 housing deposit that is non-refundable until the end of the program
- \$2,570.00 for double occupancy room in shared student apartments with A/C
 - Add \$600 to the above cost for Single Occupancy room supplement (NOT guaranteed, limited availability)
 - Add \$1,400 to the above cost for Double room used as Single Occupancy supplement (CAN be guaranteed)

VENICE TRIP OPTIONS:

Student Single Room Hotel Request: You would like to request a single room for the Venice trip for a fee of **\$150.00** to be paid directly to SRISA. This fee is non-refundable. To select this option contact SRISA at: housing@srisa.org by Tuesday, April 1st.

Add Guest: You would like to add guest/s to the Venice trip for a fee of \$750 per guest to be paid directly to SRISA. This fee is non-refundable. Guest may join the Venice trip, but are not permitted for other aspects of the program. To select this option contact SRISA at: housing@srisa.org by Tuesday, April 1st.

NOT INCLUDED:

The following costs are <u>not included</u> in the student program fee and are your responsibility. Please check mark each item to acknowledge you understand and will arrange for the following on your own:

Tuition cost (6 Units) – The cost of 6 units ArtU tuition for Summer 2025 is required and separate from the study abroad Student Program Fee. Tuition is due in accordance with ArtU standard procedures.

Flights – Your flight to/from Florence Italy is your responsibility. Do not book flights until notified by ArtU.

Housing – You will either work directly with SRISA for housing or manage your housing independently.

VISA – U.S. citizens may enter Italy for up to 90 days for tourist purposes without a visa. If you are not a U.S. citizen, contact your International Student Advisor for support. SRISA will provide a visa support letter if needed.

Health Insurance – SRISA requires participants to have a health insurance policy that covers them while abroad. If you are on a plan that covers you while abroad, you are good to go. If you need a plan, SRISA provides some resources here: https://srisa.org/information-for/enrolling-students/pre-departure-info/health-insurance/

Meals – You are responsible for your meals during the study abroad program.

April 15, 2025	Full payment of Program Fee is due to the Academy
May 1, 2025	Deadline to pay SRISA for housing, single occupancy and Venice guest fees
June 14, 2025	ArtU Summer Semester Tuition is due

REFUND POLICY: If you are unable to participate in the program, for any reason, after paying the required Student Program Fee, this refund policy will be applicable based on the date you provide notice of cancellation to the Academy. The Student Program Fee (excluding fees paid to SRISA) is 100% refundable up until May 23, 2025. You will receive a 50% refund of the Student Program Fee if you cancel between May 24, 2025 and June 6, 2025. After June 6, 2025, there will be no refunds of any kind.
