

## State Authorization Disclosures

#### **State Authorization for Online Education**

Online education providers are required to seek authorization by many U.S. states and territories to enroll their residents and those physically located in their jurisdictions. Academy of Art University restricts enrollment for applicants in and from areas where online programs are not approved. Current and prospective students are encouraged to consult the university's <a href="State Authorization for Distance Education Status Table">Status Table</a> to determine whether the Academy is authorized to offer their degree programs in the state where they will be located while taking online courses.

Students who change their residency or location are responsible for updating their home address with the university and determining whether the Academy's programs are approved by the state to which they move to avoid delays in their course of study. Relocating to a state or territory that has not authorized the university to offer online programs may cause students to lose their federal financial aid or become ineligible for professional licensure or certification.

The State Authorization Reciprocity Agreement (SARA) establishes national standards and a state-level reciprocity process that allows for the interstate offering of distance education. Membership in SARA is voluntary for states and institutions. Currently California is not a SARA state. ## **Complaint Process**

#### **School of Architecture**

Our Bachelor of Architecture and Master of Architecture are professional degree programs accredited by the National Architectural Accrediting Board (NAAB) and meet the educational prerequisites for initial licensure for the following jurisdictions:

Alabama, Alaska (Alaska applicants must either have a degree from a NAAB-accredited program or obtain an EESA evaluation to meet any deficiencies), Arkansas, Connecticut (Connecticut applicants should contact the Board directly for more information.), Washington DC, Delaware, Florida, Georgia, Iowa, Illinois, Indiana, Kansas, Kentucky, Louisiana, Massachusetts, Michigan, Minnesota, Missouri, Mississippi, Montana, North Carolina, North Dakota, Nebraska, New Jersey, New Mexico, Nevada, Ohio, Oregon, Puerto Rico, Rhode Island, South Carolina, South Dakota, Texas, Utah, Virginia, West Virginia, and? Other jurisdictions do not require a professional degree from NAAB-accredited programs for licensure.

The Bachelor of Arts in Architecture (BA), the Master of Arts in Advanced Architectural Design (MA) Track 1, and the Master of Arts in Advanced Architectural Design (MA) Track 2 programs are not accredited by NAAB and may not be accepted as meeting architectural licensure requirements in many U.S. states.

# **School of Interior Architecture & Design**

Our Bachelor of Fine Art and Master of Fine Art in Interior Architecture & Design are professional degree programs accredited by the Council for Interior Design Accreditation (CIDA) and meet the educational prerequisites for the following jurisdictions with regulations that require certification and registration to practice interior design:

Florida, Louisiana, Nevada, New York, Oklahoma, Puerto Rico, Washington DC

Other jurisdictions do not require a professional degree from CIDA-accredited programs for licensure. Some have Title Acts, where registration with the jurisdiction is optional and comes with a protected title, while other jurisdictions have no regulations in place related to the interior design profession.

Those seeking professional licensure will need to obtain pre-approval before starting the exam process.
